**HERD U NEEDED A HOME CANINE RESCUE
FOSTER CARE AGREEMENT**

I (*print name*) _____ understand that someone from Herd U Needed A Home Canine Rescue (HUNAH) will visit my home to verify my dog facilities.

If the dog I foster is on medication and/or on restricted exercise I will continue the medication and/or restrict exercise as directed. I will not let the dog outside, loose by itself, unless in a chain-link dog kennel with sides at least 6-foot tall or within another HUNAH approved exercise area. Even so, I understand that no outdoor dog exercise area is without risk of injury or escape, and I promise to check on and supervise off-leash play and exercise time for the dog(s) in my care every 15 to 30 minutes. I understand that this off-leash protocol is crucial—especially during the first few days or weeks of care depending on the temperament of the dog in question. (SOME DOGS MUST NEVER BE LET OUTSIDE OFF LEASH FOR ANY REASON—your HUNAH representative will inform you if this is the case.)

If during the time I am fostering the animal it requires medical attention I will contact a designated HUNAH representative first—unless it is an emergency. If a HUNAH representative is not available during an emergency I will attempt to take the dog under my care to one of HUNAH's approved vet partners first—then to the nearest emergency animal clinic if unable to contact one of HUNAH's approved vet partners. I understand the foster dog under my care is the property of HUNAH and I will not sell, trade or dispose of the animal. I understand the importance of my own domestic animals being up-to-date on all standard vaccinations and will provided HUNAH with a current shot record for each one prior to accepting my first dog to foster and yearly thereafter as asked.

I understand that anyone interested in adopting my foster dog must be at least 21 years of age. (Underage applicants cannot adopt from HUNAH. A parent or legal guardian must become the legal owner of the dog.) All applicants (including myself) must go through the standard adoption process. All applications must be approved prior to any meet and greet. Ultimate approval of candidates and placement of dogs is up to a designated representative of HUNAH.

I understand that although HUNAH takes reasonable care to screen dogs for foster care placement, it makes no guarantee relating to any dog's health, behavior or actions. I understand that I receive foster care dogs at my own risk and that I may reject or return any HUNAH dog(s) for any reason. In the event of a return, I promise to continue to shelter the dog(s) under my care until a new foster home may be arranged—up to and including 48 hours of my initial request through personal telephone contact with a designated HUNAH representative. If a dog must be returned in a shorter time frame due to the dog's illness, aggressive temperament, destructive behavior, etc.—or because I become incapable to continue fostering it for any reason—I promise to take the dog to a bonafide municipal animal shelter in my immediate area during business hours, or turn it over to an official animal control officer in my jurisdiction, and explain that HUNAH must be contacted as soon as possible as to the location and condition of the dog.

I acknowledge that I am a volunteer only—not a paid employee or contract worker for HUNAH. I realize that any dog is capable of predictable and unpredictable behaviors including but not restricted to herding, nipping, biting, scratching, chewing, barking, tripping, shedding, urinating, defecating, vomiting, escaping, cat killing, dog killing, and serious bodily injury and death to other animals and people. I indemnify and hold HUNAH, its Board of Directors, Executive Officers, and fellow foster families free and harmless from all liability arising out of any and all claims, demands, losses, damages, action, judgment of every kind and description which may occur to or be suffered by me, members of my household, my own animals or any third parties by reason of activities arising out of this agreement. I release HUNAH from responsibility for any diseases that may be contracted by my resident animal(s) from the foster dog(s) under my care.
